**OLD BUSINESS:**

Maureen stated she restocked the brochures in the church and Maureen re-ordered more St. Michael prayer cards for approximately \$32 for 1500 cards.

**CALL TO ORDER:**

Maureen called the meeting to order at 7:06pm. Tonight's meeting was advanced from July 6<sup>th</sup> due to a scheduling conflict with Mike and Heather Pugh.

**OPENING PRAYER:**

Hope led the opening prayer.

**APPROVAL OF MINUTES:**

Motion was m/s/c to approve the minutes of June 1, 2011.

**TREASURER'S REPORT:**

John reported we have \$550 in the bank. We paid \$1,000 to KMYC for two months of one-minute pro-life sound bites. We paid \$71 to the postmaster and \$241 to PIP for the Newsletter as well as our usual \$25 to A Woman's Friend.

**LEGISLATION:**

Mike Pugh handed out a sheet with the proposed legislation listed on it: AB433: Birth Certificate Issuance which would include those receiving hormone replacement therapy and permanent hair removal; AB499: Minors Medical Care Consent which would allow minors 12 years of age and older to consent to medical care related to the prevention of a sexually transmitted disease without parental notification. HR358: Protect Life Act: Amends the Patient Protection and Affordable Care Act (PPACA) to prohibit federal funds from being used to cover any part of the costs of any health plan that includes coverage of abortion services.

**WEBSITE UPDATE:**

Mike Pugh reported we had 1815 visits to our website last month (that does not include the 29<sup>th</sup> and 30<sup>th</sup> because the statistics were put together yesterday. The top pages viewed were for the fair, our "about" page, signs, Newsletter, and legislation.

**PLANNED PARENTHOOD PRAYER VIGIL:**

Heather gave an update on yesterday's vigil at the Planned Parenthood clinic. Heather and Hope were the only ones present, but it was successful in that Heather was able to distribute pamphlets to several individuals.

**RESPECT LIFE MEETING:**

Mike and Heather Pugh will be attending the August 27<sup>th</sup> respect life meeting for the Diocese of Sacramento outlining their implementation of the Pastoral Plan for Pro-Life Activities.

**LIFE JEWELS:**

Lou Binninger helped us to get the Life Jewels on to KMYC(1410AM). Maureen handed out an invoice from KMYC reflecting the dates and times of the segments run thus far. Maureen and John will be on KMYC this Saturday 11am-noon.

Diane has been the contact for KCYC (104.7FM). She stated that they are playing our Life Jewels three times a day. KCYC has 2 copies of CD #4.

Heather will send out an email regarding John & Maureen's interview on KMYC as well as our Life Jewels and Mike will put an announcement on our website. Heather will include an invitation for people to send an email stating if they've heard our Life Jewels.

**YUBA-SUTTER FAIR:**

Hope has been contacting people to work the fair and has four slots filled thus far. She left messages and asked people to contact her.

The fair workers evening will be July 21<sup>st</sup> at 7:00pm in the St. Isidore Dining Room.

Hope went on to the Guttmacher Institute's website and was able to obtain the 2008 abortion figures. Heather has the map for the fair on her computer and so will input the newest figures. An idea was raised to have other information for the backside of the map regarding Planned Parenthood.

Maureen did order more pamphlets called "The Morning After Pill", the Planned Parenthood tabloid and will be ordering more pens. Maureen will check with Dave Kugelman to see if he can get us some better pricing on our pens.

Maureen asked Heather/Mike to change the Petition we use at the fair to reflect the current one being used by the California Pro-Life Council but to have our information instead of theirs.

Maureen handed out "The Un-Choice Challenge" that is a 16 question sheet regarding abortion and the effects on women and teens.

Maureen handed Mike and Heather the paper with tips to add to the Fair Workers letter for this year.

Maureen passed out the Agenda for the Fair Workers Evening. Mary Anne volunteered to do the Old Testament reading at the beginning of the evening.

Diane and Fran will bring cookies (two dozen each), we will have pitchers of ice water, Heather will bring ice and iced tea, and Mary Anne will bring napkins and cups.

Hope will give an overview of the Planned Parenthood Prayer Vigil and encourage all to participate.

Fran will go to the West Coast Walk for Life website to see if they have a poster that can be downloaded and turned into a sign-up sheet for the 2012 event.

### **MISCELLANEOUS:**

Mary Anne commented that she has received a lot of positive input regarding the weekly bulletin announcements following the development of the preborn child and that perhaps we could print out all 40 of them onto a sheet as a handout. Mary Anne suggested we could have that available at the fair to hand out. Heather will put that together and email it to Maureen to have available at the Fair Worker's Evening as well as for the fair.

Human Life Alliance has updated their magazines that we have available at the area high schools and the fair. Maureen handed out the newest edition for review by those present.

Diane stated she knows someone who works at Marysville High School. Diane gave her one of the magazines, which was read by the son and daughter and they liked it so she will check to see if they can be made available at Marysville. Hope will check with a friend of hers who is the principal at Live Oak High School to see if he would be interested in having it there.

### **NEWSLETTER:**

Heather told all present Mike's idea of putting the smart phone codes in the PIP version of our Newsletter which would bring up our website or the link referenced in the article.

Heather would like to put "The Un-Choice Challenge" in the next Newsletter along with the answers.

### **ADJOURNMENT/CLOSING PRAYER:**

Our next meeting will be on Wednesday, **September 7**, 2011, at 7:00pm. There being no further business, the meeting was adjourned at 8:52 p.m. and closed with a prayer led by Maureen.
