## CALIFORNIA LEGISLATION

Contact your legislators at State Capitol, Sacramento CA 95814, to express your support for the following pending legislation:

**Partial Birth Abortion Legislation (SB 1827):** This legislation would ban the PBA, which partially delivers, and then kills, a baby.

**Parental Consent for Release from Schoolgrounds (AB 1749):** This proposed legislation states that school officials may not allow pupils in grades K through 12 to leave school campus **without permission of the parent or guardian.** In other words, the school nurse or staff from your friendly neighborhood abortion clinic could no longer take your daughter to obtain birth control or receive an abortion.

**State Senate:** Yuba & Butte Counties (except Gridley): Sen. Tim Leslie; Sutter & Colusa Counties & Gridley: Sen. Maurice Johannessen.

**State Assembly:** Yuba & Butte Counties (except Gridley) Assemblyman Sam Aanestad; Sutter & Colusa Counties & Gridley: Assemblyman Dick Dickerson

## FETAL TISSUE RESEARCH

The following is from an ABC News press release: "A three-month '20/20' hidden-camera investigation has uncovered an industry in which tissue and organs from aborted fetuses, donated to help medical research, are being marketed for hundreds, sometimes thousands, of dollars."

If you did not see the report which aired March 8, the program left no doubt about the fact that aborted babies are being used in medical research. (Does this sound like something out of Hitler's Germany?) But the focus of the story was not outrage that such research is being conducted; rather, the outrage was directed against those who PROFIT from it.

The California ProLife Council newsletter further reports that Planned Parenthood placed paid advertisements in the *Sacramento News & Review* to defend the practice of using aborted baby body parts for medical experimentation.

This is another area where we need to let our legislators know we strongly oppose the selling of body parts.

## ABORTION NUMBERS DECLINE

Nationwide, over the last decade the number of abortions in the U.S. has declined 15%, from 1.6 million in 1988 to 1.36 million in 1996 (the last year for which statistics are available). The percentage of pregnancies that end in abortion has also dropped, from 33% to 25%.

In California, Medi-Cal funded (your tax dollars) abortions declined 43%!

These numbers are headed in the right directions, but our mission won't be accomplished until we can report NO abortions are taking place.

## RU 486 UPDATE

It is widely known that President Clinton wants approval granted for this chemical abortifacient before he leaves office but the FDA has yet to grant final approval. This form of abortion kills a child and is no less immoral than a surgical abortion.
