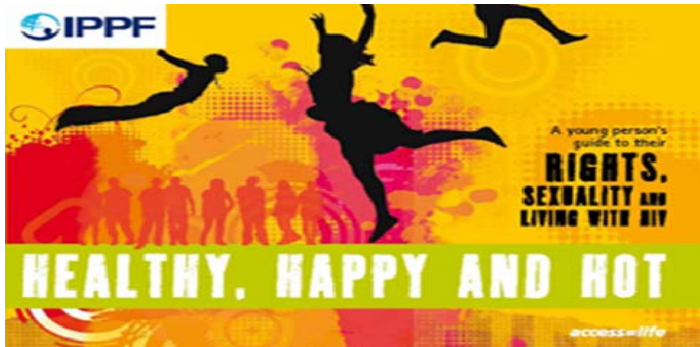

### IN THE NEWS:

March 11, 2010—New York (C-FAM). The World Association of **Girl Scouts** and Girl Guides hosted a no-adults-welcome panel at the United Nations at which Planned Parenthood was allowed to distribute a brochure



entitled “**Healthy, Happy and Hot.**” The brochure, aimed at young people living with HIV contains explicit and graphic details on sex, as well as the promotion of casual sex in many forms. The brochure claims, “**Many people think sex is just about vaginal or anal intercourse... But, there are lots of different ways to have sex and lots of different types of sex. There is no right or wrong way to have sex. Just have fun, explore and be yourself!**”

**The brochure also tells students that national laws requiring HIV-positive people to reveal their status to their partner(s) “violate the rights of people living with HIV” and calls for advocacy to “change laws that violate your rights.”** It explains, “**There are many reasons that people do not share their HIV status. ... They may worry that people will find out something else they have kept secret, like they are using injecting drugs, having sex outside of a marriage or having sex with people of the same gender.**”

Also, the heads of various powerful UN agencies including the UN Population Fund, UN Educational, Scientific and Cultural Organization (UNESCO), UN Children's Fund and the World Health Organization released a joint statement under the name of the “UN Adolescent Girls Task Force,” which calls for their agencies to promote and support programs “that empower ... adolescent girls, **particularly those aged 10 to 14 years.**” One of the chief priorities for empowerment is ensuring access to

“life-skills based **sexuality education**, HIV prevention, and sexual and reproductive health.”

Wendy Wright, president of Concerned Women of America told the Friday Fax, “Governments and NGOs should be aware of Planned Parenthood’s insidious plan to work with UN agencies and girls’ organizations in order to **profit from encouraging kids to be sexually active.**”

## PRO-LIFE PRESENTATION TRAINING A SUCCESS!

On Saturday, May 8th, myself and other pro-lifers attended a pro-life presentation training given by Kathleen Deluca at the home of Yuba-Sutter Right to Life's president, Maureen Guth. I found the training enlightening and came away excited to share some of my new-found knowledge. For those of you who wanted to attend but were unable, you can find much of what we learned in a 69-page book entitled "[PRO-LIFE 101: A Step-by-Step Guide to Making Your Case Persuasively](#)". ### **1. If *Roe v. Wade* were reversed, women would die from back-alley abortions.**

The statistics used by pro-aborts concerning the number of women who died from illegal abortions were falsified by Dr. Bernard Nathanson, co-founder of NARAL ("*Confession of an Ex-Abortionist*" by Dr. Bernard Nathanson.) The fact is that in the year prior to the legalization of abortion, **39** women died from "back-alley abortions" compared with the 1.3 million children being killed annually in legal abortions.

### **2. I'm against abortion except in the case of rape or incest.**

Abortion in the case of rape or incest is the killing of an innocent child as punishment for a crime committed by the father of the child. It is the death penalty imposed on the innocent to cover up the crime of the guilty. Men who commit rape and incest LOVE abortion because the evidence (the child) to convict them is eliminated! The fact is that abortion is the biggest enabler of these hideous crimes.

### **3. Many poor women cannot afford another child.**

Perhaps so, but when human beings get expensive, may we kill them? What would we think of a mother who killed a toddler who was taxing the family budget or the teenager who was "eating them out of house and home"? Killing a child is wrong regardless of their size, age or effect on our budget. Besides, countless couples are eager to adopt! The number of couples wanting to adopt has not changed, but the number of babies placed for adoption has fell drastically since the legalization of abortion. With adoption, both the mother and the child can have the life they dream of.
