IN THE NEWS:

June 1, 2011—Washington, D.C. (LifeSiteNews.com) - [The US Food and Drug Administration \(FDA\) is conducting a safety review](#) of multiple brands of birth control pills containing drospirenone, a synthetic female sex hormone.

Bayer, the maker of several of the oral contraceptives whose effects the FDA is reviewing, faces 7000 lawsuits from women who say the drug manufacturer misrepresented the dangers associated with using [the birth control Yaz](#). Side effects include stroke, cardiac arrest, blood clots, and gallbladder problems—similar to those of other birth control pills.

Bayer has marketed *Yaz* to teenagers and young adult women touting its product as not only for preventing pregnancy, but also for treating Premenstrual Dysphoric Disorder (PMDD) and acne.

One wrongful death lawsuit involves an [18-year-old New Jersey college student who died of cardiac arrest](#) after taking *Yaz* for acne treatment. A blood clot had lodged in her lungs resulting in her sudden death on her way to classes on September 24, 2010.

The FDA noted on its public announcement that “[a]ll birth control pills pose a risk of blood clots,” but two studies posed in the [British Medical Journal](#) contended that the contraceptives containing drospirenone posed two to three times a greater risk than other contraceptives containing levonorgestrel.

Bayer said it will conduct a study of 800,000 women in order to resolve the conclusions of conflicting studies on drospirenone-containing contraceptives. The results of the study are due sometime in the summer.

June 28, 2011—Indianapolis (LifeSiteNews.com) Recently, Indiana passed [House Enrolled Act \(HEA\) 1210](#) which, among other things, requires a physician who performs abortions to 1) inform the woman seeking an abortion that the fetus might feel pain and 2) show the pregnant woman fetal ultrasound imaging unless the woman states in writing that she does not wish to view it. Naturally, Planned Parenthood of Indiana (PPIN) filed suit to block the law, including the provision that doctors must tell women seeking abortions that “human physical life begins when a human ovum is fertilized by a human sperm.” This request was denied by U.S. District Judge Tanya Walton Pratt.

Planned Parenthood claimed the phrase was “misleading”. “When read together, the language crafted by the legislature in this provision supports a finding that the mandated statement refers exclusively to a growing organism that is a member of the *Homo sapiens* species,” wrote Pratt. The court continued, “Under Indiana law, a physician must disclose the facts and risks of a treatment which a reasonably prudent physician would be expected to disclose under like circumstances, and which a reasonable person would want to know.”

Another provision of the law bars federal Medicaid funds from going to the abortion provider. The judge did grant Planned Parenthood’s injunction request against that part of the same law.

Tom Brejcha, president and chief counsel of the [Thomas More Society](#), praised the judge for upholding scientific fact, but said that they would continue to ensure that the measure defunding Planned Parenthood goes into effect. “While this is a significant partial victory for Life, we will press on to ensure that the full law will go into effect to defund Planned Parenthood in Indiana, Brejcha said. “We stand ready to defend Life in other states as they plan to defund Planned Parenthood and require doctors to tell women that life begins at conception.”

July 21, 2011—Austin, TX (LifeSiteNews.com) [Rick Perry](#), governor of Texas and 2012 GOP presidential candidate, has signed SB7 into law. This measure excludes abortion providers and their affiliates from the Medicaid Women's Health Program and also places Planned Parenthood at the bottom of the list of eligible recipients of family planning funds. Lawmakers in Texas also drastically cut the state's pool of these funds in June from \$100 million to roughly \$38 million.

SB7 also prevents hospital districts from using tax funding for elective abortions and encourages adult stem cell research by giving health officials authority to regulate adult stem cell banks.

Perry's signature places Texas among several other states depriving Planned Parenthood of funding in its state budget this year, including Indiana, Kansas, New Jersey, and North Carolina.

August 18, 2011—Texas (LifeSiteNews.com) Planned Parenthood is closing clinics and merging affiliates throughout Texas after funding cuts that came about as a result of the bill signed into law by Governor Perry. "Even though these clinics are family planning clinics, so there's not actually any abortions being provided at the clinics that are closing their doors, there's no mistake that these are abortion-minded clinics that are sending women to abortion clinics," commented Texas Right to Life Legislative Director John Seago. Texas funds stripped from family planning organizations have been reallocated to pregnancy centers, among other programs.

July 21, 2011—LifeSiteNews.com [A Discover Magazine online article](#) published July 6 examined the outcome of years of experiments by [Dr. Joseph Giacino](#), director of rehabilitation neuropsychology at Spaulding Rehabilitation Hospital, and [Nicholas Schiff](#), a Weill Cornell Medical Center neurologist, as they probed the distinction between reflexes and "real cognition" in patients labeled as being in a "[persistent vegetative state](#)" (PVS). "These are human beings who seem to have lost their humanity," Giacino told the magazine. "The question is, is that really the case?"








Several studies, one as late as 2009, have found that as many as 41% of PVS patients had some level of awareness, and the evidence keeps building.

Schiff called his first experience with an awakening "truly surreal" when he discovered that his very first PVS patient was speaking three years later. Spurred by that experience, he and Giacino examined more PVS patients. In one case, the team marveled as the neural activity of one man deemed minimally conscious "flared up" just like a healthy brain at the sound of his mother's voice.

Another patient woke up abruptly after 19 years of minimal consciousness and began to speak fluently. Later, a scan found that his brain was sprouting new connections, something "nobody would have believed" possible with a decades-old injury without picture proof.

"The implications of their work are haunting. It suggests that many of the estimated 250,000 to 300,000 or more people in this country languishing in bedrooms and nursing homes with disorders of consciousness are probably still 'in there' - still have some capacity to think and to feel and might, in a limited way, be able to rejoin the world," states the article.
